Membership & Other Fees with effect from 2008-2009

The Membership & Other Fees with effect from 1st April, 2008 are as follows :

Associate Annual Membership Fee : Rs.500/- p.a. (Rs.100/- p.a. for members entitled to pay at reduced rate)

Associate Entrance Fee : Rs.600/-

Fellow Annual Membership Fee : Rs.1000/- p.a. (Rs.150/- p.a. for members entitled to pay at reduced rate)

Fellow Entrance Fee : Rs.500/-

Certificate of Practice Fee : Rs.500 p.a.

Membership & Restoration Fee for All arrears of membership and other fees plus 20% of such arrears plus removed members : current year's fee

Grad. CWA Fee : Rs.200/- p.a.

The fees may be paid by Cash/Demand Draft/Cheque at the Headquarters/Regional Council offices/Chapters of the Institute. The Demand Draft/Cheque should be drawn in favour of "The ICWA of India" and payable at Kolkata. In case of outstation cheque, Rs.30/- is to be added towards Bank Charges.

NOTE : MEMBERS SHOULD ENSURE TO INDICATE THEIR NAME AND MEMBERSHIP NO. ON THE REVERSE OF CHEQUE/DEMAND DRAFT TO BE DRAWN IN FAVOUR OF "THE ICWA OF INDIA" PAYABLE AT KOLKATA IN CASE PAYMENT IS TENDERED BY CHEQUE/DEMAND DRAFT. IT SHOULD ALSO BE ENSURED NOT TO ENCLOSE ANY OTHER INTIMATION ETC. ALONG WITH THE REMITTANCE OF MEMBERSHIP FEE.

Members Benevolent Fund : Rs.500/- (one time payment) by a Demand Draft favouring 'ICWA of India
Subscription (Life Membership) Members Benevolent Fund' drawn on any nationalised bank payable at Kolkata only.

The Annual Membership Fee for 2008-2009 for Associate and Fellow Members of the Institute has become due and payable on 1st April, 2008 at the following rates :

Associate Annual Membership Fee : Rs.500/- (Rs.100/- for members entitled to pay at reduced rate)

Fellow Annual Membership Fee : Rs.1000/- (Rs.150/- for members entitled to pay at reduced rate)

The last date of payment of membership fee has expired on **30th September, 2008**. Members are requested to pay their respective membership fees along with arrears, if any, immediately to keep their membership alive.
